Action regarding Cancellation of December 15, 2020 City Council Meeting Summary: The cancellation of the December 15<sup>th</sup> City Council Meeting was briefly mentioned at the November 3<sup>rd</sup> City Council Meeting. The consensus of the Council was to cancel the December 15<sup>th</sup> City Council Meeting unless an emergency item comes up.
  - c. Action regarding Acceptance of a Quitclaim Deed from Sabine Valley Industries, Inc. for E. Cement Creek Drainage Improvements

Summary: The City's Capital Improvement Program includes drainage improvements for E. Cement Creek. The project is under design by Kimley-Horn and Associates, Inc. and is nearing design completion. During property research, surveyors discovered a remainder of property, owned by Sabine Valley Industries, Inc. (Sabine Valley), within the existing drainage channel of E. Cement Creek. Sabine Valley has provided a Quitclaim Deed conveying its interest in the property less the mineral interests. There will be no financial impact.

d. Action regarding setting date for Public Hearing for Update to Land Use Assumptions, Capital Improvements Plan, and Water Impact Fees

Summary: As part of the impact fee adoption process, a public hearing is required. The date of the public hearing must be advertised thirty (30) days in advance of the public hearing. The anticipated date for the public hearing and impact fee adoption is January 5, 2021.

- e. Action regarding Acquisition of a Permanent Drainage Easement at 400 Opal Street Summary: The City's Capital Improvement Program includes drainage improvements for E. Cement Creek. The project is under design by Kimley-Horn and Associates. Inc. and is nearing design completion. The design requires that the City obtain three Permanent Drainage and Utility Easements for properties along Opal Street. On July 7, 2020 City Council authorized an agreement with Tom Kaiser, MAI. a Real Estate Appraiser, to perform appraisals for the three easements to determine the value of the taking. One of the easements is on Lot 10, Block 1, Rancho North Addition (400 Opal Street) owned by Jeffery and Lisa Crago. Mr. Kaiser determined that the value of the taking with damages for the Crago's property is \$4,600. Staff met with Mr. Crago to review the offer. After negotiations with Mr. Crago, a final offer of \$5,500 was made. Staff recommends this offer be accepted to avoid additional costs with negotiations and the potential for condemnation. Funding is available in the Drainage Fund, Account 14-7000-00, Capital Outlay/Special Request.
- f. Action regarding Acquisition of a Permanent Drainage Easement at 304 Opal Street Summary: The City's Capital Improvement Program includes drainage improvements for E. Cement Creek. The project is under design by Kimley-Horn and Associates, Inc. and is nearing design completion. The design requires that the City obtain three Permanent Drainage and Utility Easements for properties along Opal Street. On July 7, 2020 City Council authorized an agreement with Tom Kaiser, MAI, a Real Estate Appraiser, to perform appraisals for the three easements to determine the value of the taking. One of the easements is on Lot 8, Block 1, Rancho North Addition (304 Opal Street) owned

by Lori Hernandez and Christopher Lugo. Mr. Kaiser determined that the value of the taking with damages for Ms. Hernandez and Mr. Lugo's property is \$2,700. Staff met with Ms. Hernandez and Mr. Lugo to review the offer which they accepted. Funding is available in the Drainage Fund, Account 14-7000-00, Capital Outlay/Special Request.

g. Action regarding Building Improvement Grant Agreement with Sunshine Playhouse (808 Longhorn Rd.)

Summary: On Tuesday, November 3, 2020, the City Council heard information in Executive Session pertaining to the specifics of a Building Improvement Grant (BIG) Program application submitted during October 2020 by Sunshine Playhouse regarding their property located at 808 Longhorn Road. The City Council determined in that session to award an amount not-to-exceed \$5,000 in reimbursable, and matching, dollars for the anticipated improvements as proposed on their application. The proposed agreement is the realization of that intent. Funding is available in Account 01-6142-13, Building Improvement Grants.

h. Action regarding Building Improvement Grant Agreement with El Pasito LLC (124 W. McLeroy Blvd.)

Summary: On Tuesday, November 3, 2020, the City Council heard information in Executive Session pertaining to the specifics of a Building Improvement Grant (BIG) Program application submitted during October 2020 by El Pasito LLC regarding their property located at 124 W. McLeroy Blvd. The City Council determined in that session to award an amount not-to-exceed \$5,000 in reimbursable, and matching, dollars for the anticipated improvements as proposed on their application. The proposed agreement is the realization of that intent. Funding is available in Account 01-6142-13, Building Improvement Grants.

 Action regarding Agreement with SpyGlass Group, LLC for an Audit of current Telecommunications Service Accounts

Summary: The proposed agreement authorizes SpyGlass to review current telecommunication agreements the City has with different providers to identify cost recoveries, service elimination savings, and cost reduction savings. SpyGlass will make recommendations to City Staff and coordinate any changes to current agreements authorized by Staff. SpyGlass will not be compensated unless SpyGlass finds a refund due to the City or the City makes changes to telecommunication agreements as a result of the audit. The City is under no obligation to implement any of the audit recommendations. The financial impact will be determined by the action taken by the City after reviewing the audit.

j. Action regarding Interlocal Agreement with Tarrant County for Construction and Expansion of the Parking Lot at the north end of Willow Creek Park, serving Willow Creek Station Park (the Dream Play Area) as well as the Reconstruction and Asphalt Overlay of the Existing Parking Lot

Summary: The proposed interlocal agreement with Tarrant County includes the expansion of the parking lot at the north end of Willow Creek Park as well as the reconstruction and asphalt overlay of the existing parking lot. As in previous agreements, Tarrant County will furnish the labor and equipment. The responsibilities of both Tarrant County and the City are specified in the proposed Agreement. The proposed agreement has been approved by Tarrant County. Funds to cover this project are available in the 2020-2021 Street Maintenance Fund Budget.

Mayor Flippo stated that Item 4h will be removed from the Consent Agenda for separate consideration and action.

### (5) Presentation of "THE ESSENTIALS: THE FRONT LINE HEROES OF SAGINAW" BOOK

Mrs. Malinda Julien of Julien & Lambert Photography briefly explained the recently completed book titled "THE ESSENTIALS: THE FRONT LINE HEROES OF SAGINAW". She expressed her appreciation to everyone that participated. She explained that she felt it was important to recognize the front line workers from various businesses and groups in Saginaw. She added that a copy of the book was given to the John Ed Keeter Public Library during a book signing event earlier today.

# (6) Presentation by Mural Artist

Mr. Adam Davenport addressed the Council. He has painted two murals in Saginaw and is in the process of completing a third mural. He presented a proposal for painting a 16,200 sq.ft.(180' tall x 90' wide) mural on the end of the grain silo owned by Attebury. The total cost would be \$400,000. The consensus of the Council was to proceed with getting more information regarding the proposed mural, location, and funding for future consideration.

#### (7) Farmer's Market at Saginaw SwitchYard Update

Mr. Trey Harper, Director of Development at Community Link Mission, addressed the Council. He expressed his appreciation for the partnership with the City in regards to the Farmer's Market. He gave a brief update on the success of the Farmer's Market. He introduced Ms. Hannah Walker, Farmer's Market Coordinator. They gave a video presentation of the market and participating vendors. Plans for 2021 were discussed as well as ways to include more vendors. There was some concern expressed about Saginaw residents not being allowed to become vendors. Mr. Harper explained a rubric that gives preference to Saginaw residents is used as part of the vendor application process.
