SUBJECT: Action regarding Ordinance No. 2015-06, Amending the Master Fee Schedule to Add Fee for Junk Dealer/Secondhand Dealer; and Amend Recreation Center and Aquatic Center Usage/Membership and Rental Fees

BACKGROUND/DISCUSSION:

Ordinance No. 2015- 06 addresses amendments to the Master Fee Schedule. The amendments include the addition of the fee for a Junk Dealer/Secondhand Dealer. This fee is in the City Code but not listed on the Master Fee Schedule. The remaining amendments include changes to the several usage and rental fees charged at the Recreation Center and Aquatic Center. Fees at these facilities have not been updated in many years.

ORDINANCE NO. 2015-06

AN ORDINANCE OF THE CITY OF SAGINAW, TEXAS, AMENDING THE MASTER SCHEDULE OF FEES ESTABLISHED BY ORDINANCE NO. 2010-14, AS AMENDED, ADDING THE FEE FOR JUNK DEALER/SECONDHAND DEALER; AND AMENDING RECREATION CENTER AND AQUATIC CENTER USAGE/MEMBERSHIP AND RENTAL FEES; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE OF ALL ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Saginaw, Texas (the “City”) is a home rule city acting under its charter adopted by the electorate pursuant to Article XI, Section 5, of the Texas Constitution and Chapter 9 of the Local Government Code; and

WHEREAS, the City has heretofore adopted a Master Schedule of Fees for City services and permit applications; and

WHEREAS, the City desires to amend the Master Schedule of Fees to add the fee for Junk Dealer/Secondhand Dealer, and amend the Recreation Center and Aquatic Center Usage/Membership and Rental Fees, in order to reflect the administrative costs incurred by the City to perform the function associated with these applications.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAGINAW, TEXAS:

SECTION 1.

That the Master Schedule of Fees established pursuant to Ordinance No. 2010-14, as amended, is hereby amended by adding the fee for Junk Dealer/Secondhand Dealer, and amending the Recreation Center and Aquatic Center Usage/Membership and Rental Fees, in order to reflect the administrative costs incurred by the City to perform the function associated with these applications. The new fees are set forth in the attached and incorporated Exhibit “A”, hereto.

SECTION 2.

The City Secretary is hereby directed to revise the Master Schedule of Fees in accordance with the above-referenced revision. A revised Master Schedule of Fees shall be kept on file with the office of the City Secretary.

SECTION 3.

This Ordinance shall be cumulative of all provisions of the Code of Ordinances of the City and other applicable City ordinances, except where the provisions of this Ordinance are in direct conflict with the provisions of such ordinances, in which event the applicability of the conflicting provisions of such ordinances are hereby repealed.

SECTION 4.

It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses, and phrases of this Ordinance are severable, and if any section, paragraph, sentence, clause, or phrase of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining sections, paragraphs, sentences, clauses, and phrases of this Ordinance, since the same would have been enacted by the City Council without the incorporation in this Ordinance of any such unconstitutional section, paragraph, sentence, clause or phrase.

SECTION 5.

This Ordinance shall be in full force and effect from and after its passage and it is so ordained.
