



## **Registration Information for Dogs/Cats Saginaw Animal Services**

Saginaw City Ordinance requires that all dogs and cats residing within the city limits be currently licensed with Saginaw Animal Services. Each household may have a total of either (3) dogs and (2) cats, OR (3) cats and (2) dogs. That number does not include puppies and kittens less than 4 months of age; however it does include foster and other temporary dogs and cats.

In order to be licensed with the city, dogs and cats must be CURRENTLY vaccinated against rabies. A Rabies Vaccination Certificate will need to be provided to Saginaw Animal Services in order to verify that your pets are current. If you no longer have the Rabies Certificate that would have been provided by your veterinarian, you can usually call and request that a copy be sent to you from your veterinarian. You'll want to keep these for your records, as Rabies Certificates are often asked for if you groom, board, or go out in public with your pet because Texas State Law does require current rabies vaccination. If you need information on low cost vaccination services, you can call the shelter at 817-230-0460.

If you are registering your pet with the city for the first time, you will need to come to the Saginaw Animal Shelter in person. You do not have to bring your pet, but please remember to bring your Rabies Certificate and I.D. or Driver's License. Please keep in mind, payments made at the shelter under \$10.00 must be cash or check.

If you are simply renewing your pet's city license, you can come to the shelter in person, or you can print, complete, and mail in the Registration Application on this page. To mail in your registration, please include the completed Registration Application, a COPY of your pet's current Rabies Certificate, and your payment. Once your registration form has been received at the shelter, staff will issue you a new city license, and will mail your proof of registration, license tag, and receipt back to you.

Cost of registration for 1 year is:

- \$10.00 per animal, 1 year

In some cases, you may be eligible for a 3 year registration. To be eligible, your pet must have been given a 3-year Rabies Vaccination within the past 30 days. If you qualify, simply check "( ) 3yr" under "City License" on your Registration Application. Shelter staff will verify eligibility, and will call you if there are any questions.

Cost of registration for 3 years is:

- \$30.00 per animal, 3 years
